## 1. SCOPE

- 1.1 This Carbon Reduction Plan covers all activities of Brickfield Consulting Limited.
- Brickfield Consulting's operations are entirely within the United Kingdom.
  - Brickfield Consulting does not have any subsidiary or parent companies.
- 1.2 Brickfield Consulting recognises the value that having a Carbon Reduction Plan brings to measuring its carbon emissions and providing a framework for reducing them. With effect from 1<sup>st</sup> April 2024, Brickfield Consulting will begin to measure its carbon emissions, with the following 12 months (1<sup>st</sup> April 2024 – 31<sup>st</sup> March 2025) being established as our Baseline Year.
- 1.3 Brickfield Consulting commits to:
- Measuring its total carbon emissions on an annual basis, aligned to its financial year.
  - Consolidating its carbon emissions data within 3 months of the end of each financial year.
  - Identifying changes in its operations and other initiatives to reduce its carbon emissions within 6 months of the consolidation of its carbon emissions data.
  - Publishing an updated Carbon Emissions Plan by 31<sup>st</sup> March each year.

## 2. COMMITMENT TO ACHIEVING NET ZERO

- 2.1 Brickfield Consulting commits to achieving net zero carbon emissions by 2050.
